### VOLUNTEERING

Parents should be prepared to volunteer their time and energy to help with FAST related activities. In addition, when FAST enters swim meets we will submit a list of timers to the Meet Manager in advance of the meet to ensure we are in compliance with Potomac Valley Swimming guidelines.

### FAST MEETS

Our club hosts meets annually and needs participation from every family. For the 2011 / 2012 season we will be hosting five meets.

### FINANCIAL

FAST generates its revenue from Program Dues and hosting swim meets. Each family has an obligation to make sure they are current with program dues and meet fees, and to volunteer with hosting meets. Being a small team, we don't have a 'war chest' of money so please meet established deadlines.

Families with outstanding program fees are not eligible for discounts the following season and might be required to pay the full seasons dues prior to the first practice.

As of 2011, meet fees have been rolled into program dues. Families will now have an invoice with only one charge.
